How to Know You Win

The Fraternal Department will announce the winners live on the <u>Modern Woodmen Fraternal Leaders</u> <u>Closed Facebook Page</u>. If your name is drawn, you'll receive a congratulatory email from the Fraternal Department.

These awards may be reportable to you as income from Modern Woodmen in the tax year the gift is received. They will be added to any compensation paid to you directly by Modern Woodmen, and you will receive a 1099 form for any compensation totaling \$600 or more in the same tax year. According to the IRS, regardless of the cost of an award or its fair market value, cash or cash equivalent awards (including gift certificates/cards), recognition awards (cash and non-cash) for job performance, and awards for performance are taxable as wages to an individual unless they qualify as a de minimis award/prize. Cash and cash equivalent awards such as gift certificates/cards are never considered de minimis.
