### Membership coordinator

- Helps promote chapter events.
- Hosts events, greeting and socializing with attendees.
- Connects members and guests to others.
- Attends 1-2 board meetings a year.

### President

- Works closely with the activities coordinator\* to lead board meetings.
- Attends 1-2 board meetings a year to help plan and share ideas.
- Attends and helps with chapter activities, when possible.

### Vice president

- Fills in when the president is unavailable.
- Attends 1-2 board meetings a year to help plan and share ideas.
- Attends and helps with chapter activities, when possible.

### Trustee

- Attends 1-2 board meetings a year to help plan and share ideas.
- Attends and helps with chapter activities, when possible.

\*The activities coordinator oversees fraternal activities for the chapter, including planning, promoting and reporting the activities.

## FREQUENTLY ASKED QUESTIONS

**How much time will I spend as a chapter board member?** 1-2 hours per month, at most.

**How long do I serve as a chapter board member?** Chapter board members are voted on annually.

**What's in it for me?** Make a difference in your community for causes you care about. Make new friends, learn new skills and enjoy new experiences! Be part of Modern Woodmen's legacy of helping people and communities since 1883.

**Do I have to be a Modern Woodmen member to serve on a chapter board?** Yes. You must be a beneficial member. Talk to a local representative to learn more about the benefits of membership.

**Do I have to be a member of the chapter in which I serve as a board member?** Yes. Contact your local representative if you think you are not in the correct chapter.
